Due by Interview (April)	45-hours Early Field Experience	Observation of a CA Credentialed Teacher for a minimum of 45 hours <ul style="list-style-type: none"> <li>• Must be TK-8 and in multiple subjects classroom</li> <li>• Must be in a contained classroom</li> <li>• Will accept up to 22.5 hours from previous teaching work experience</li> <li>• Course fulfilling this requirement offered at Cal Poly Humboldt: SED 210/410</li> </ul>
June 30	Certificate of Clearance	Prior to being allowed into any classroom(s) during the credential program, candidates must obtain clearance from the CTC in the form of <b>one of the following</b> : <ul style="list-style-type: none"> <li><input type="checkbox"/> <a href="#">Certificate of Clearance</a></li> <li><input type="checkbox"/> 30-day Sub Permit</li> <li><input type="checkbox"/> Provisional Intern Permit</li> <li><input type="checkbox"/> Short Term Staffing Permit</li> </ul> Must be a valid document throughout the length of the credential program.

August 1	US Constitution Course or Exam	Met <b>one of the following</b> ways: <ul style="list-style-type: none"> <li><input type="checkbox"/> CSU Graduates meet this requirement with degree</li> <li><input type="checkbox"/> Undergraduate course that covers the principles and provisions of the US Constitution, passed with a C- or better</li> <li><input type="checkbox"/> Take the exam: <a href="http://www.usconstitutionexam.com/">http://www.usconstitutionexam.com/</a></li> </ul>
August 1	Health Verification (do not submit via email!)	<input type="checkbox"/> Submit proof of Measles, Mumps, Rubella (MMR) vaccination from your records or Cal Poly Humboldt Health Center records <i>If you do not have these records, ask your doctor for a titre test to show you have had the vaccination</i> <input type="checkbox"/> Current Tuberculosis (TB) screening (within the last 2 years)

All program requirements listed above ***must be submitted no later than August 1st at 5pm*** in order to register for the program that year. Start early on completing the Certificate of Clearance and Subject Matter Competency requirements as these take the greatest amount of time to complete and are the most likely to be delayed or held up.

#### **Other Notes**

We are a two semester program that starts in the Fall and finishes in the Spring. We encourage candidates to remain at their placement sites even when Cal Poly Humboldt is not in session. **Please be prepared to be available for the duration of the program.**

#### **Submit the completed application online by the deadline**

Not all of the program requirements listed above must be completed by the time you submit your application. That being said, the more requirements completed early, the better position you will be in.

The School of Education Credential Program advising committee will conduct applicant interviews in late March, interviews in April, and admission notices will follow. Subject Matter Departmental Reviews can only take place if all official transcripts have been received by Cal Poly Humboldt.
